## **Image Use Policy and Conditions** **Susan B. Anthony House**

### **Conditions of Use:**

1. All reproductions must be made from photographic materials supplied by the Susan B. Anthony House. Reproductions from printed or other non-photographic materials, or from photographic materials not supplied by the Susan B. Anthony House, is strictly prohibited. CDs may not be used for reproductions purposes unless special permission is granted by the Susan B. Anthony House.
2. Permission for reproduction is granted for only one usage in one publication, for one edition in one language. Addition language editions and subsequent revised new editions will be considered upon request. **Images are not to be duplicated, scanned electronically, or otherwise copied without prior approval by the Susan B. Anthony House. If duplicated, any copies/scans are to be sent to the Susan B. Anthony House when publication is complete.**
3. All images are rented, not purchased or sold.
4. Each image must be reproduced in its entirety. Reproduction may not be cropped or bled off the page, nor may anything be superimposed on the reproduction. At its discretion, the Susan B. Anthony House may request proofs, and the borrower will make all corrections deemed necessary by the Susan B. Anthony House to ensure faithful reproduction. The Susan B. Anthony House reserves the right to revoke permission if, in its opinion, the borrowing institution has not obtained acceptable standards of reproduction.
5. The following credit line must be shown in immediate proximity to the reproduction, or in the section of the publication or production (television/film/video) devoted to acknowledgements:

6. The Susan B. Anthony House does not supply images to companies or individuals operating a photograph rental and/or sale service. No photographic materials may be made by outside companies or photographers for commercial purposes without the prior written consent of the Susan B. Anthony House.
7. The Susan B. Anthony House can grant the permission requested only to the extent of its ownership of the rights relating to the request.
8. The borrower agrees to indemnify the Susan B. Anthony House and hold it harmless against all such claims, including copyright infringement claims, royalty or fee demands

and/or actions, including the costs thereof, arising as a result of the borrower's reproduction.

9. Upon publication, the borrower must provide at least one copy of the publication (or appropriate tear-sheet) in which the reproduction appears. It should be sent to the Susan B. Anthony House.
10. Images approved for web use may be renewed for up to six months at a time for an additional fee.
11. **Pre-payment is required, and must be received by the Susan B. Anthony House within one month of the date this agreement is signed by the borrower, or the agreement will become null and void. Additional charges or fees may apply in some cases.**
